The pension shall thus be made in lump sum payment.  行政院於 102 年曾審議「公立學校教職員退休極鄉條例草案」,與會人員咸認為具我國國籍者須未喪失我國國籍或外國籍教師須取得我國國籍者始得釋領月退休金,並建議修正國籍法,放寬外籍人士申請歸化我國國籍時,得不必放棄其原有國籍、使外國語教師等得具有雙重國籍,俾符合擇領月退休金規定,以利延攬並吸引優秀外籍人才來臺任教。目前有關國籍法條文修正草案,業退立法院審議中。 Executive Yuan of Taiwan examined the draft of public school faculty and staff retirement in 2013 and determined that foreign teachers can claim monthly retirement pension payment after retirement only if they acquire the citizenship of the Republic of China. To make this condition to be fulfilled more easily for foreign teachers, the Executive Yuan of Taiwan have made official claim to urge the revision of Nationality law to allow foreign teachers to have dual nationalities so that they can acquire the citizenship of Taiwan without giving up their original nationality. Personnel Office will urge all the academic departments and administrative offices, both by emails and during the various administrative meetings of NCKU, to make sure that they inform foreign candidates of their job openings about the regulation of the lump sum payment of the retirement pension for foreign employees of NCKU while doing the interviews with those candidates for their consideration for career planning.

# 2. Benefits to Foreign Faculty

Foreign teachers are entitled to the same benefits with the domestic staffs of NCKU, including marriage subsidy, giving birth subsidy, funeral subsidy (the death of parents, spouse or children), children education subsidy, birthday certificate and physical check-up.

# 3. Annual Leave Issue

依本校「教師申請出國作業要點」第3點規定略以,為免影響教學,教師申請出國觀光、探親,應利用寒、暑假、春假及其他假日辦理。同要點第4點規定略以,上課期間申請出國處理私人事宜,事由以參加子女結婚、探視直系親屬重病或參加個人畢業論文口試、畢業典禮為原則,期限以一星期為原則。

First, according to the Article three of the National Cheng Kung University Guidelines to Go Abroad for Teachers, to minimize the disturbance of the teaching schedule of the academic semesters, teachers should utilize winter/summer vacation, spring break, or other holidays to travel to other countries for the purposes such as visiting relatives and sightseeing. Additionally, according to the Article four of this Guidelines, teachers can only be allowed to go abroad in the middle of the academic semesters for specific personal matters as follows: attending children's wedding, visiting close relatives (e.g., children, grandchildren, parents, and grandparents) who are seriously ill, attending personal oral defense for acquiring official academic degree, and attending personal graduation ceremony for academic achievement. The length for such leaves should be no more than seven days.

Second, based on the Leave of Absence Regulation of NCKU, after working at NCKU for one year, professors are entitled to a total of 7 days

leave per academic year for personal matters.

Third, the faculty members of NCKU can go abroad for personal matters on the condition of no interference of the educational rights of students. Foreign faculty members can go abroad on spring break or other holidays (such as new year holidays) as well.

## 4. Translator Secretary is Needed

本校目前外籍教師、研究人員共 30 名。其中日籍專任教師 3 人、專案教師 1 人、專案研究人員 1 人,先予說明。 First, for your information, NCKU has 30 foreign faculty members and research fellows. Among them, there are five NCKU employees who are from Japan, including three tenure-track professors, one Project Professor, and one Project research fellow.

上開外籍教研人員來自不同國家,除日本外尚有美國、葡萄牙、德國、澳大利亞、瑞典、俄國、馬來西亞等國家,故採國際通用語言(英語)服務上開教研人員。現行作法除對內開辦相關英語課程鼓勵同仁加強英語能力外,對外更以語文能力加給提高薪資,增加延攬優秀人員誘因。案內建議聘請日文翻譯部分,考量各行政單位業務繁雜具專業性,並非嫻熟日文即能提供服務,且在不同行政單位運用國際通用語言(英語),更可依其專業服務各國教研人員,發揮最大效益。嗣後將請各單位遞補人員時,依實際需要將相當英語能力列為必要資格條件。

Second, In addition to those 5 Japanese NCKU employees, foreign teachers and research fellows at NCKU come from various countries, including the United States of America, Portugal, German, Australia, Sweden, Russia, and Malaysia, and thus we consider English as the common language for serving those foreign NCKU employees. To better serve our foreign colleagues at NCKU, we develop English training programs to encourage our administrative staff to enhance their English communication skills, and give higher salary package to administrative staff who are determined to be highly capable of using English for communication. Regarding the suggestion of hiring Japanese translator, because administrative issues are complicated and beyond the comprehension of fluent Japanese speakers without proper professional training, it is better to use common international language (e.g., English) to communicate with our foreign employees. Therefore, we will encourage all the administrative offices and departments of NCKU to take English communication ability as an important criterion for determining the qualification of applicants of their job openings in the future.

# 5. Raise Salary

我國公立大專校院教師薪給係依「全國軍公教員工待遇支給要點」、「教師待遇條例及其施行細則」等相關規定訂定教師(年功薪)、 學術研究費標準表,係屬固定性薪給,爰本校無法自行加薪。

According to Regulations Governing the Payment of Remuneration to Military, Public and Teaching Personnel and the Payment Regulations and Act of Teachers, NCKU is subject to fixed salary and we cannot offer any NCKU employees a raise by ourselves.

至薪資調整部份係由行政院依「全國軍公教員工待遇支給要點」辦理年度待遇調整,最近一次調薪為 100 年 7 月調整幅度 3%。 The adjustment of salary is performed based on Regulations Governing the Payment of Remuneration to Military, Public and Teaching Personnel. The latest raise of 3% occurred in 2011.

Because blocking the roads around our campuses may result in serious transportation and traffic problems, and thus it may not be feasible from the perspective of the authority. In addition, the method of constructing intern-building underground tunnels or bridges needs to be evaluated carefully regarding various issues, such as cost-effectiveness issues, we are afraid that it may not be feasible either in the short term. Office of General Affairs will continue to work with Tainan City Government to improve the safety on the roads around our campuses by the design and deployment of more effective traffic signal systems.  2. We advise that faculty members who want to make such purchases should ask the administrative staff of their department to help them clear the relevant issues with the staff of the Purchasing Division of the Office of General Affairs.

For example, such living guides could include information such as the following: "For any individual who has income from sources in the Republic of China, comprehensive income tax shall be declared in accordance with the Act Comprehensive Personal Income Tax during the period from May 1 to May 31 each year. Tax payers should fill out tax declaration form and file it to the authority based on his or her gross consolidated income of the preceding year.  [國際事務處回覆]  Staff of the Office of International Affairs is currently working on developing a website for International Scholars that contains information of the online resources regarding living in Taiwan and NCKU campus environment. However, the Office of Academic Affairs just informed us that due to budget cut we need to reduce the total classes by increase the class capacity to 38 students per class. In this case, we can only offer no more than three classes to the undergraduate students, and perhaps no class for the graduate students.
	The Foreign Language Center is a self-sufficient organization, and, unfortunately, is not part of the university academic system. Thus, it does not have regular teaching staff, nor budget from the university, to offer free service to the students.

# **Open Issue**

#### 1. Professor A:

Starting from the beginning of this year, I have a foreign postdoc joining me at NCKU for 18 months. He is not paid by NCKU, rather his salary is paid by Swiss National Science Foundations. In order for him to come to NCKU to work with me, he will need to have a residence permit and for that NCKU would need to employ him formally. I started looking into last year but it turned out that, apparently, NCKU does not have an existing protocol to deal with such situations. Rather, we have to go through an employment procedure under 頂尖大學計劃 and because of this, he is only officially hired until the end of the year. What this means is that we will need to go through another round of hassles in order for him to continue his employment until the end of 18 months. To me, this sounds absolutely ridiculous! What have someone coming from overseas to work for us for free, but we are not at all ready to take advantage of such opportunities. If NCKU really wants to become an international university, something has to be done to make things easier for such opportunities in future.

#### 2. Professor B:

Private foundations prizes for research, monographs etc. are limited for the citizens only. Could the same be done for the professors of Taiwan schools? Prize money of a foreigner could go to the school, not to the researcher/professor.
